Mayor Starr called the meeting to order at 7 p.m.

Councilmember Mike Frnka gave the invocation and all present recited the Pledge of Allegiance.

Mayor Starr stated there will be a work session held on the second Monday of each month at 7 p.m. to set the agenda and have discussion. The meeting is open to the public and will be posted on the Town's website.

Mayor Starr also gave information in regards to the Yard Sale and Town Festival scheduled for the 17th of June. Information for the yard sale is posted at Town Hall and on the Town's website. Shawn Banach stated he can have this advertised with The Bear.

The Council briefly discussed an ordinance for becoming a Tree City, City Attorney Mark Mitchell will work on an ordinance to present to the Council at the next meeting.

Councilmember Harris made a motion to approve Estimate # 4236 from Adams-Massey Co, LLC in the amount of \$13783.15 for the replacement of the well pump, to be paid from SPLOST funds. Seconded by Councilmember Frnka. Vote: All in favor
