REGULAR COUNCIL MEETING

Present: Mayor Alan Starr, Councilmembers Cindy Purcell, George Harris, Alan Stapp and Mike Frnka; Town Clerk Tracey Townsend and City Attorney Mark Mitchell.

Mayor Alan Starr called the meeting to order at 7 p.m.

Councilmember Frnka gave the invocation and all present recited the Pledge of Allegiance.

Councilmember Stapp made a motion to accept the agenda as presented, seconded by Councilmember Frnka. Vote: All in favor

Councilmember Frnka made a motion to accept the following minutes

May 15, Regular Council Meeting with the amendment being made on page 2,  $1^{st}$  Paragraph, changing the second from Harris to Frnka

June 12, Council Workshop

seconded by Councilmember Harris. Vote: All in favor.

Mark Mitchell gave an example for the Tree Ordinance

Councilmember Frnka made a motion for adoption of the resolution for the Mayor to sign the Intergovernmental Agreement between Coweta County and the Town of Turin regarding SPLOST, seconded by Councilmember Harris. Vote: All in favor

Councilmember Frnka made a motion for adoption of the resolution to adopt the project list, seconded by Councilmember Harris. Vote: All in favor

Mayor Starr stated that the Water Contract with Sharpsburg has been accepted and signed by both towns, a copy has been made and distributed to all Councilmembers.

Councilmember Frnka made a motion to accept the website proposal with 11 Fingers, seconded by Councilmember Stapp. Vote: All in favor

Mayor Starr asked for the work sessions to be rescheduled for the 3<sup>rd</sup> Monday of each month at 6:30 p.m. This will be prior to the Regular Monthly meeting.

Mayor Starr discussed a feature he wants added to the Town's website: A Suggestion Box, this will be for the public to make suggestions, have them emailed to the Clerk who can then send out to the Council.

Councilmember Stapp made a motion to approve the cost of \$1565, by the Coweta County shop for the Town Hall Library, seconded by Councilmember Frnka. Vote: Councilmembers Harris, Stapp and Frnka in favor, Councilmember Purcell opposed. Motion Carries

Mayor Starr stated the library will consist of pine shelving along with a kid's corner and three computer kiosks for public use.

Mayor Starr discussed getting costs for refinishing the Community Center's floors, Councilmember Purcell suggested the windows, roof and other areas need to be addressed before moving on the floors. Mayor Starr stated the project committee would do a re-evaluation for the Community Center.

No updates from Planning & Zoning committee.

Mayor Starr gave an update on the water system, the pump has been installed, but it still being evaluated with the installers and Georgia Power.

Margarette Bolden, 420 Turin Road stated she has not received any written notices from the Water System, she stated she also wanted to know more in regards to the library.

Shawn Banach, 214 Railroad Street, spoke to the Council on several topics

He also thinks the website proposal is being offered at a good price.

He also stated that during the work session the public should be given a chance to speak.

There was also a comment about the yard sale, he stated this was a good thing and next year he hopes to work together and have it done right.

Proceeds from the sale was \$600 and was donated to the historical society, also he agrees with Margarette, that the Town needs a historical society.

Susan Reimer, 152 Odom Road also said the yard sale did have a good turn out and it was also good to have it coincide with the Chicken Q held by Tractor Association.
