REGULAR COUNCIL MEETING

Present: Mayor Alan Starr, Councilmembers Mike Frnka, Fernando Ramos, Alan Stapp and Clarence Bolden; Town Clerk Tracey Townsend and Attorney Mark Mitchell

Mayor Starr called the meeting to order at 7:04 p.m.

Councilmember Mike Frnka gave the invocation and all present recited the Pledge of Allegiance.

Councilmember Stapp made a motion to approve the agenda, seconded by Councilmember Bolden. Vote: All in favor.

Councilmember Bolden made a motion to approve the minutes from the regular meeting of March 19, 2018 and from the Budget Public Hearing on April 9, 2018, seconded by Councilmember Stapp. Vote: All in favor

Councilmember Frnka made a motion to adopt a resolution in accepting the FY2018 Operating Budget, seconded by Councilmember Stapp. Vote: All in favor

Councilmember Bolden made a motion to adopt a Resolution for Certified City of Ethics, seconded by Councilmember Stapp. Vote: All in favor. The Resolution along with the Ethics Ordinance that was approved in 2012 will be submitted to the Georgia Municipal Association.

Councilmember Bolden made a motion to table the 5-year Capital Improvement Plan to May 21, 2018, seconded by Councilmember Frnka. Vote: All in favor

The Inter-Governmental Agreement in regards to the Animal Control (shelter) was discussed and Town Attorney Mark Mitchell informed the Council that he was waiting on a response from Coweta County. Table to May 21, 2018

Councilmember Bolden made a motion to approve and execute an Inter-Governmental Agreement with Coweta County relating to the reimbursement of costs associated with North Road as a part of the 2018 Full Depth Reclamation Project, seconded by Councilmember Stapp. Vote: All in favor.

Councilmember Stapp made a motion to approve Judge Stokely as the Municipal Court Judge of Turin, seconded by Councilmember Bolden. Vote: All in favor

Councilmember Bolden made a motion for approval to make a grant application in regards to a Farmer's Market, seconded by Councilmember Frnka. Vote: All in favor

A Special Events permit was discussed by the Council.

Downtown Development Authority: Clarence Bolden, Mike Frnka. Town Attorney Mark Mitchell will get the statute requirements. Table to May 21, 2018

Planning & Zoning updates – Susan Reimer informed the Council that the two new members have been to the required training classes.

Water System update – Repairs caused by construction on Hwy 154 and North Road were completed last week by Rusty Russell and he is completing the flushing schedule.

Randy Hogan, 47 Water Oak Drive, made a comment in regards to the fence around the pumping station. Mayor Starr replied that he has spoken with Jay Boren of Coweta County Water & Sewer Authority and they have agreed to work with the Oaks of Turin HOA for the fencing and landscaping. CCWSA will pay for the materials and the Town of Turin will maintain.

Susan Reimer, 152 Odom Road, asked about the fees that will be paid to Judge if we move forward with the Municipal Court, and if a permit would be required for town functions, and also, she would love to help with getting people to volunteer for committees

County Commissioner Paul Poole was recognized in the audience and informed all present he was available at any time for their needs.

Councilmember Bolden gave thanks to Commissioner Poole and stated that he was present for the listening session and it was a great turnout. He also gave thanks to Susan Reimer for wanting to volunteer her time.
